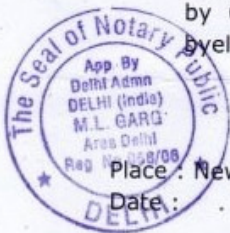
1. That DAV College Trust and Management Society, New Delhi/ DAV College Managing Committee is a registered Trust/Society under the Societies Registration Act.
